- **c.** It was agreed that the committee would receive a copy of the monthly phone call statistics of the Buchanan Police Department from 2019 -2020.
- **d.** The panelists agreed that additional meetings were needed in order to meet the April 1, 2021 deadline for the submission of the reform plan.
- e. Ideas on how to meet new residents, both homeowners and renters, were discussed.
